TESTIMONY

At 0130 Hrs. on 03/03/99 I was working stationary radar patrol in the 200 blk. on SE 12TH Av. I noticed a white 1996 Honda Accord traveling southbound. I had noticed the same vehicle driving the area earlier that morning. I left my position and entered 12TH also southbound. Upon entering 12TH I noticed the vehicle accelerate and make a quick turn westbound onto Boyd St. the vehicle then made another quick turn onto Jami Dr. before pulling into the driveway at 1428 Jami. The driver exited the vehicle and walked towards the front door of the residence as if he was going to enter. I turned around and traveled back northbound on Jami watching the driver in my rearview mirror. As I drove away the driver turned back around and walked towards his vehicle. I ran a check on the license plate that was displayed on the vehicle (FAV197) the tag was registered to a 1985 Honda Accord. I parked around the corner waiting for the subject to leave. After a short wait, the subject did not leave. I then drove back onto Jami Dr. and noticed that the driver was now walking northbound on Jami. Upon seeing me the driver quickly turned around to walk away from me. I contacted Mr. Jones in front of 1410 Jami. He stated that he did not live where he had parked and that he did not know who lived there. He added that he had pulled into the driveway in an attempt to avoid me because he thought I was going to stop him. Jones stated that his driver's license was inside of his vehicle that was still parked in front of 1428. Off. Hart arrived as a backing officer. Myself Off. Hart and Mr. Jones walked to his vehicle to retrieve his license. Before entering the car, I asked Jones where his license was located and he said that it was in the center console. Upon entering Jones immediately placed his left hand on the floorboard of the drivers side, grabbing a loaded 380-caliber Lorcin handgun and attempted to shove it under the drivers seat. Jones was immediately taken into custody without incident. Upon further investigation, I ran a registration check on the VIN number of the vehicle. Dispatch advised that the vehicle was stolen out of Oklahoma City on 02/04/99. Jones also had a pair of cotton gloves and a pair of women's pantyhose in his back pocket. Jones was transported to CCDC and booked in on charges of unauthorized use of a motor vehicle and possession of a firearm during the commission of a felony. The firearm, gloves, and pantyhose were booked into Norman Police property custody.

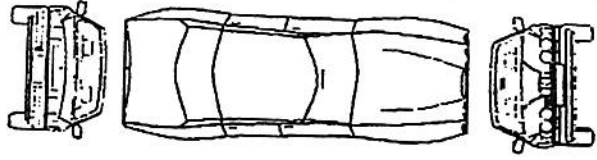

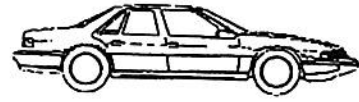
