LEGAL OWNER ENTERPRISE RENT-A-CAR

ON 7-21-99 AT 2213 I RECEIVED A CALL TO THE HIDEAWAY PIZZA AT 6616 N. WESTERN IN REFERENCE TO A CARJACKING.

UPON ARRIVAL, I MET WITH THE VI AND TWO WITNESSES WHO STATED THAT THEY WERE LEAVING THE RESTAURANT WHEN A BLACK MALE IN HIS TWENTIES STUCK A SMALL "SHINY" SEMI-AUTO IN THE VICTIM'S FACE AND DEMANDED THAT THE VI GIVE HIM THE KEYS TO THE VI'S CAR. THE SU THEN TOLD THE VI AND WITNESSES TO GET IN THE CAR WITH HIM. THEY REFUSED AND THE SU LEFT IN THE CAR SOUTHBOUND ON WESTERN.

THE CAR IS A 98 LEXUS RX300 RED IN COLOR AND IS AN ENTERPRISE RENT-A-CAR. NO TAG INFORMATION WAS AVAILABLE.

THE SU WORE A BLUE BANDANNA OVER HIS MOUTH AND HAD DARK CLOTHES ON.

BODY OF REPORT

ON 7/23/99 AT 2200 HOURS, MYSELF AND LT. D. PATTY, #0577, WERE WORKING IN PLAIN CLOTHES AT 6616 N. WESTERN IN AN ATTEMPT TO LOCATE THE SUSPECT OF TWO CAR JACKINGS IN THIS LOCATION OCCURRING ON 7/21/99 AND 7/22/99. IT SHOULD BE NOTED THAT 6616 N. WESTERN IS "HIDEAWAY PIZZA".

UPON COMPLETION OF SURVEILLANCE OF THE BUSINESS, THE MANAGER, [REDACTED] BROUGHT US BACK TO THE OFFICE TO VIEW THE SECURITY TAPES OF 7/21/99 AND 7/22/99. VIEWING THE VIDEO FOR WEDNESDAY, 7/21/99, WE OBSERVED A VEHICLE BACK INTO A PARKING SPACE ON THE EAST SIDE (REAR SIDE) OF THE BUSINESS, THIS WAS AT 2142 HOURS. THIS VEHICLE SAT WITH NO ACTIVITY AROUND THE VEHICLE FOR SEVERAL MINUTES UNTIL A SUBJECT EXITED THE VEHICLE ON THE PASSENGER SIDE, RAN FROM THE VEHICLE, LOOKING BACK ONCE AT THE CAR BEFORE HE WENT OUT OF VIEW ON THE CAMERA. IT SHOULD BE NOTED THIS SUBJECT RAN SOUTHBOUND BEHIND THE BUSINESS.

A FEW MINUTES LATER, THIS SUBJECT RETURNED ON THE NORTH SIDE OF THE BUILDING AND HAD SEEMED TO CIRCLE THE BUILDING. THIS SUBJECT THEN WENT BACK TO THE CAR, GOT BACK IN THE PASSENGER SIDE AND THE VEHICLE EXITED EAST AROUND THROUGH A PARKING LOT AT 2152 HOURS. THE SUBJECT IS A BLACK MA WEARING WHAT LOOKED TO BE LIGHT COLORED, ALTHOUGH THE VIDEO TAPE WAS NOT CLEAR ON COLORS AND IT DIDN'T DISTINGUISH DARK OR LIGHT COLORS WELL, DUE TO THE TAPE BEING BLACK AND WHITE AROUND 2205 HOURS ON THE VIDEO TAPE. THE TAPE CUT OUT AND DIDN'T CAPTURE THE VICTIM COMING BACK IN THE BUSINESS. THE TAPE SKIPPED AND WENT TO 2300 HOURS.

IT SHOULD BE NOTED THAT THE TAPE IS A FOUR SPLIT SCREEN THAT SHOWS THE FRONT (WEST) LOBBY AREA, THE KITCHEN AREA, EAST DINING AREA AND THE EAST BACK PARKING LOT. BOTH TAPES WERE BOOKED INTO THE PROPERTY ROOM, 7/21/99, TAPE UNDER 99-062836 AND 7/22/99 TAPE UNDER 99-063237. FOR INFORMATION FOR THAT TAPE SEE SUPPLEMENTAL UNDER CASE 99-063257.
