BODY OF REPORT:

ON 7/22/99 AT APPROX 2214, OFFICER'S WERE DISPATCHED TO 6616 N WESTERN ON A CAR JACKING IN PROGRESS. UPON ARRIVAL, OFFICER'S WERE MET BY VI [REDACTED] AND WITNESSES, WHO SAID AS THEY WERE LEAVING THE HIDEAWAY PIZZA RESTAURANT.

VI [REDACTED] WAS APPROACHING HIS NEW VEHICLE, WHICH WAS PARKED IN FRONT. AS HE APPROACHED HIS VEHICLE, A BLACK MALE WEARING A BLACK BALL CAP AND BLUE BANDANA APPROACHED HIM WITH A SMALL BLACK SEMI-AUTOMATIC BEING HELD IN HIS RIGHT HAND.

THE BLACK MALE SAID TO VI [REDACTED] "GIVE ME THE KEYS. GIVE ME THE KEYS", AS THE SUSPECT POINTED THE GUN AT HIM. VI [REDACTED] HANDED THE BLACK MALE THE KEYS WHERE HE GOT INTO THE VEHICLE, STARTED IT AND SPED SOUTH FROM THE AREA ON WESTERN. THE VEHICLE WAS LAST SEEN TRAVELING WEST ON NW 63RD FROM WESTERN.

NEITHER THE VICTIM OR WITNESSES WERE HURT DURING THIS CAR JACKING. AT THIS TIME, THE VIN NUMBER OR NEW PAPER TAG INFORMATION IS KNOWN, WHICH WILL BE CALLED BACK TO OFFICER'S WHEN IT IS OBTAINED.

A LARCENY OF MOTOR VEHICLE STATEMENT WAS OBTAINED AND SIGNED BY VI [REDACTED]. THE VEHICLE WILL BE ENTERED NCIC WHEN IDENTIFICATION IS OBTAINED.

AT APPROXIMATELY 2345 HOURS, RUSCHER WAS ADVISED VI [REDACTED] HAD NOTIFIED CIU WITH THE PROPER VIN NUMBER FOR HIS STOLEN VEHICLE. THE VEHICLE WAS THEN ENTERED NCIC BY CIU.

BODY OF REPORT:

ON 072399 AT 2200 HOURS, MYSELF AND LT. D. PATTY, 0577, WERE WORKING IN PLAIN CLOTHES AT 6616 N. WESTERN AV., HIDEAWAY PIZZA IN AN ATTEMPT TO LOCATE THE SU OF TWO CARJACKINGS AT THIS BUSINESS ON 072199 AND 072299.

UPON COMPLETION OF SURVEILLANCE OF THE BUSINESS AND SURROUNDING AREA, THE MANAGER OF HIDEAWAY PIZZA, [REDACTED], BROUGHT US TO THE OFFICE TO VIEW THE SECURITY TAPES OF 072199 AND 072299.

UPON VIEWING THE TAPE FROM 072299, WE NOTED NO SUSPICIOUS ACTIVITY UNTIL THE VI AND WIS WALKED OUT OF THE BUSINESS. THE VI AND WIS WALKED OUT OF THE BUSINESS AT 2213 HOURS. IT SHOULD BE NOTED THAT THIS VIDEO IS A FOUR WAY SPLIT AND COVERS THE WEST, FRONT LOBBY AREA, THE KITCHEN AREA, EAST DINING AREA, AND THE EAST, BACK PARKING LOT.

THE VIS AND WIS WERE VIEWED ON THE WEST, FRONT LOBBY AREA. AT 2214 THE VI CAME BACK IN THE BUSINESS AND WAS POINTING OUTSIDE AND SEEMED TO BE EXCITED. THE WIS CAME IN PROMPTLY AFTER THE VI. IT SHOULD BE NOTED, THIS COVERAGE OF THE EAST LOBBY IS AN INSIDE CAMERA AND DID NOT CAPTURE THE INCIDENT OUTSIDE THE PARKING LOT. THE VIDEO DID CAPTURE THE HEADLIGHTS OF THE VI'S CAR SEEMING TO GO NORTHBOUND ON WESTERN AV.

ON 7/26/99 THIS SGT CONTACTED VI. [redacted] AND INTERVIEWED HIM ON HIS CAR BEING STOLEN FROM HIM. VI. [redacted] STATED THAT HE HAD EATEN DINNER WITH THE HIS FRIENDS (WITNESSES LISTED ABOVE) AND WENT OUT TO HIS CAR. HE WAS STANDING BY HIS CAR ON THE DRIVER SIDE WHEN THE SUSPECT RAN UP FROM THE STREET AND PUT A GUN TO HIS HEAD. THE SUSPECT DEMANDED HIS KEYS AND ONCE HE GOT THE KEYS, VI. [redacted] WENT BACK INSIDE THE BUSINESS. VI. [redacted] STATED HE COULD NOT IDENTIFY THE SUSPECT.

THIS SGT THEN INTERVIEWED WI. [redacted] ON THIS ROBBERY. HE STATED THAT HE WAS OUTSIDE WITH VI. [redacted]. HE SAW THE SUSPECT APPROACHING VI. [redacted] WITH A CHROME LOOKING GUN, POSSIBLE AN AUTOMATIC. HE TURNED AS THE SUSPECT REACHED VI. [redacted] AND WENT INSIDE AND CALLED 911. WI. [redacted] STATED THAT HE DID NOT THINK HE COULD IDENTIFY THE SUSPECT. HE DID DESCRIBE HIM AS A BLACK MALE, BAGGY PANTS, THIN BUILD AND AROUND 5'8" IN HEIGHT.

WI. [redacted] WAS ALSO INTERVIEWED ON THIS ROBBERY ON THIS DATE. SHE STATED THAT SHE HAD GONE OUT WITH THE GROUP AND WAS AT THE CAR WHEN THE SUSPECT APPROACHED. SHE STATED THAT ONCE THE ROBBERY STARTED SHE WALKED BACK INSIDE THE BUSINESS AND WAITED FOR THE POLICE.

WI. [redacted] STATED THAT SHE WAS INSIDE HER CAR WHEN THE ROBBERY STARTED AND HAD HER DOORS LOCKED. SHE STATED SHE DID NOT NOTICE ANYTHING UNTIL SHE SAW THE SUSPECT POINTING THE GUN AT VI. [redacted]. SHE STATED SHE WAS ABLE TO WATCH THE SUSPECT AS HE TOOK THE KEYS FROM VI. [redacted] AND WORKED ON STARTING THE CAR. SHE STATED THAT SHE CAN IDENTIFY THE SUSPECT IF SHE SAW HIM AGAIN. SHE DESCRIBED THE SUSPECT AS HAVING A BANDANNA OVER HIS FACE FROM HIS NOSE TO HIS NOSE, NO BASEBALL CAP BUT SHORT CUT HAIR, 5'8" IN HEIGHT AND A SMALL BODY SIZE.
